2006 Teacher of the Year Is a One-Woman Show

With a supporting cast up the highway at Lakeshore Technical College (LTC), Sharon Abel is the "whole show" when you look at



adult educational programming at the Sheboygan County Detention Center (Jail). Of the counties fortunate enough to have on-site educational offerings for adult inmates, methods of delivery vary. In Sheboygan County, the method is Sharon Abel.

Since 1991, LTC has employed Sharon Abel to provide Adult Basic Education to the incarcerated

population in Sheboygan County. Sharon delivers General Education Development Certificate/High School Equivalency Diploma preparation, basic skills review, college preparation services, and much more to approximately 200 offenders each year.

In recognition of Sharon's commitment to bring quality education to her students, her efforts to expand programming beyond traditional classroom instruction, and her advocacy of the important role that education plays in the future success of those incarcerated in our penal system, the Executive Board of CEAW is proud to honor Sharon Abel as the 2006 Wisconsin Correctional Teacher of the Year.

Sharon is employed by Lakeshore Technical College. Sharon's Bachelor of Science Degree with a Major in Secondary Education English and a Minor in Business is from Northern Michigan University. In 1998, Sharon received an M.S. Degree in Career & Technical Studies from University of Wisconsin-Stout. Since then, she has earned an additional 32 graduate credits with emphases in Behavior Management and Financial/Economic Literacy.

Since her employment with LTC began over 14 years ago, Sharon Abel has continued to expand the educational offerings at the Sheboygan County Detention Center. In addition to basic literacy and GED/HSED instruction, Sharon has introduced learning activities that emphasize financial/economic, family, and computer literacy. Her efforts give inmates the opportunity to develop the fundamental tools needed to obtain, retain, and upgrade employment. Sharon helps her students gain a sense of self-worth and confidence necessary to live an alternative lifestyle to their criminal past.

Aware of the great need for recreational and informational reading materials to supplement the instruction she was providing, in 1998, Sharon Abel along with Huber Law Officer Roy Kluss acted on their own and on behalf of the inmates to create a partnership with the fiscal agent Eastern Shores Library System in an effort to obtain a \$5000 grant for library materials from the Sheboygan County Crime Prevention Fund. Each year, Sharon has written a grant request to continue funding the library project. Sharon and volunteer Sue Mathews order the books which are sent to Sharon who recruits the assistance of Correctional and Maintenance staff to disburse the books through Sheboygan County's various jail facilities: adult male, adult female, and juvenile housing units; lobbies, waiting areas, and visiting rooms.

After seven years of funding, the Sheboygan County Crime Prevention Fund was dissolved and Sharon is now pursuing other methods of obtaining library materials for the inmate library. Recently she recruited another volunteer to help receive "gently" used materials and cash donations to purchase new materials.

Drawing on her own past experience as a Literacy Council tutor, Sharon and other LTC personnel have partnered with the Literacy Council of Sheboygan County to solicit volunteers to come into the Detention Center to assist inmates in improving their reading skills. The tutor initiative has provided an inter-generational experience for her students and has enhanced instruction.

Sharon Abel has been an outstanding advocate for correctional education. She has published articles on the subject in professional journals and presented workshops at state and national conferences. Recent in-services and conferences Sharon has presented at or participated in include: Association of Community College Trustees National Leadership Congress, Sheboygan County Leadership Institute, Sheboygan County Hispanic Resource Fair, Wisconsin GED/HSED & Adult Literacy Conference, and National Institute on Financial & Economic Literacy. To promote community awareness, Sharon has spoken about correctional education before the Sheboygan Bar Association, the Sheboygan City Council, other local agencies and a group of State Senators and Representatives.

Sharon's energy and leadership abilities have enabled her to forge the partnerships necessary to implement a unique educational program at the Sheboygan County Detention Center. In addition to working with her colleagues at Lakeshore Technical College, she routinely teams with staff at Sheboygan County Sheriff's Department, Sheboygan County Job


Center, Eastern Shores Library System, the Literacy Council of Sheboygan County, Good News Jail & Prison Ministry, and local K-12 schools. Daily she works with Jail Administrator John Scholke and Huber Law Officer Roy Kluss to coordinate the education program with other jail functions. Judges, Probation/Parole Officers, Public Defenders and District Attorneys are some of Sharon's biggest fans, realizing the impact her work has on her students and the community.

But most of all, her students appreciate the energy and excitement Sharon brings to everything she does. Comments like "Sharon is a very understanding and caring instructor that really cares," "Sharon is the easiest person to talk to and does a terrific job teaching," "She instilled in me a desire to do the best I could do," and "She gave me a feeling of selfworth and is one of the main reasons I am now a productive citizen in the community" are commonly heard.

Sharon's educational philosophy can be summed-up by the charge written on her classroom board: "Enter to learn; Go forth to serve." Sharon puts this charge into action.

Creative Crocheters at KMCI



Inmates at Kettle Moraine Correctional Institution learn the rewards of hard work and the spirit of giving by participating in the Restorative Justice Crochet Program called Creative Crocheters. They crochet a variety of items which are then donated to non-profit agencies for distribution to the disadvantaged.

Approximately 20 men participate in the program. They meet twice a week on Mondays and Wednesdays or Tuesdays and Thursdays, from 12:45pm to 1:35pm. In addition to class time, the men spend countless hours in their housing unit productively, and artfully practicing their crochet skills.

The rewards to the inmates are numerous, and include but are not limited to:

- the development of patience and perseverance, the enhancement of thought skills
- the intensification of focus, better eye & hand coordination
- creative expression
- an increase in self-esteem from the knowledge that they are helping others

A variety of crocheted articles are displayed three to four times a year in the school hallway display case. The display is designed and executed by the inmates, and follows a seasonal theme. The most recent display was a Christmas theme of red, white, and green crocheted articles on a white background, and adorned with downy snow.

Some of the program participants, and staff chose to write their names on a Christmas star to hang in the display case. We received many favorable comments. One person stated, "It's a real morale booster for inmates and staff."

First-Ever Governor's Financial Literacy Awards Announced

The Financial Literacy program taught by Lori Koening at the Stanley Correctional Institution was one of the first-ever winners of the Governor's Financial Literacy Award selected by the Governor's Council on Financial Literacy (GCFL).

Eleven individuals and five organizations will receive the 2006 awards which were created to recognize excellence in increasing financial literacy among Wisconsin citizens.

The honorees were selected by the GCFL based on nominations received from the Council's Awards Committee. The evaluation of nominees was based on four criteria: innovative implementation, demonstrated measurable results, collaboration with partners and scope—either statewide or having the potential to be statewide or focused to need-based groups.

"Congratulations to each of these distinguished individuals and organizations," said Governor Jim Doyle. "Their hard work to promote financial education has made Wisconsin the recognized national leader when it comes to financial literacy. They richly deserve this honor for their sustained, enthusiastic commitment and I thank the Council for recognizing them. I also encourage them to continue their efforts to improve financial literacy in Wisconsin," added Governor Doyle.

The social and economic costs of financial ignorance are great. Money problems are the leading cause of divorce and a leading cause of suicides. Stress caused by money worries among workers results in low morale, low productivity, theft, fighting, absenteeism, tardiness and other problems that hurt the bottom line of employers and ultimately the economy.

Today's youth appear to be following in their parents' financial footsteps. In a nationwide study conducted in 2004 by the National Jumpstart Coalition (NJC), Wisconsin 12th graders achieved an average score of 54.7 percent on a test of their financial knowledge. While it was above the national average of 52.3 percent, the score remains an "F" on any grading scale. The NJC will release the results of a new nationwide survey in April.

Governor Doyle created the Governor's Council on Financial Literacy in early 2005 to advise him on how to improve the financial literacy of Wisconsin's citizens. First Lady Jessica Doyle is the Honorary Chair of the Council.
