Alliances with the American Correctional Association, the American Jail Association, Office of Correctional Education, GEDTS and other national and international organizations.

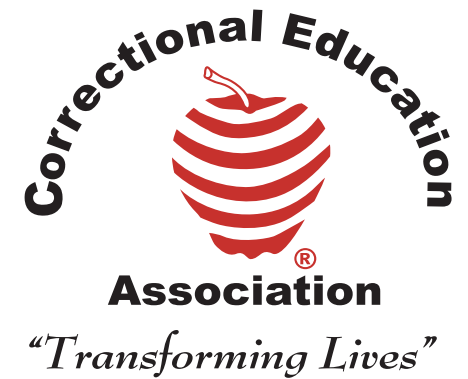
An opportunity to network with other correctional educators at national and regional conferences along with the Annual International Conference and Leadership forum.
